4 reasons to invest in Galati Free Trade Zone

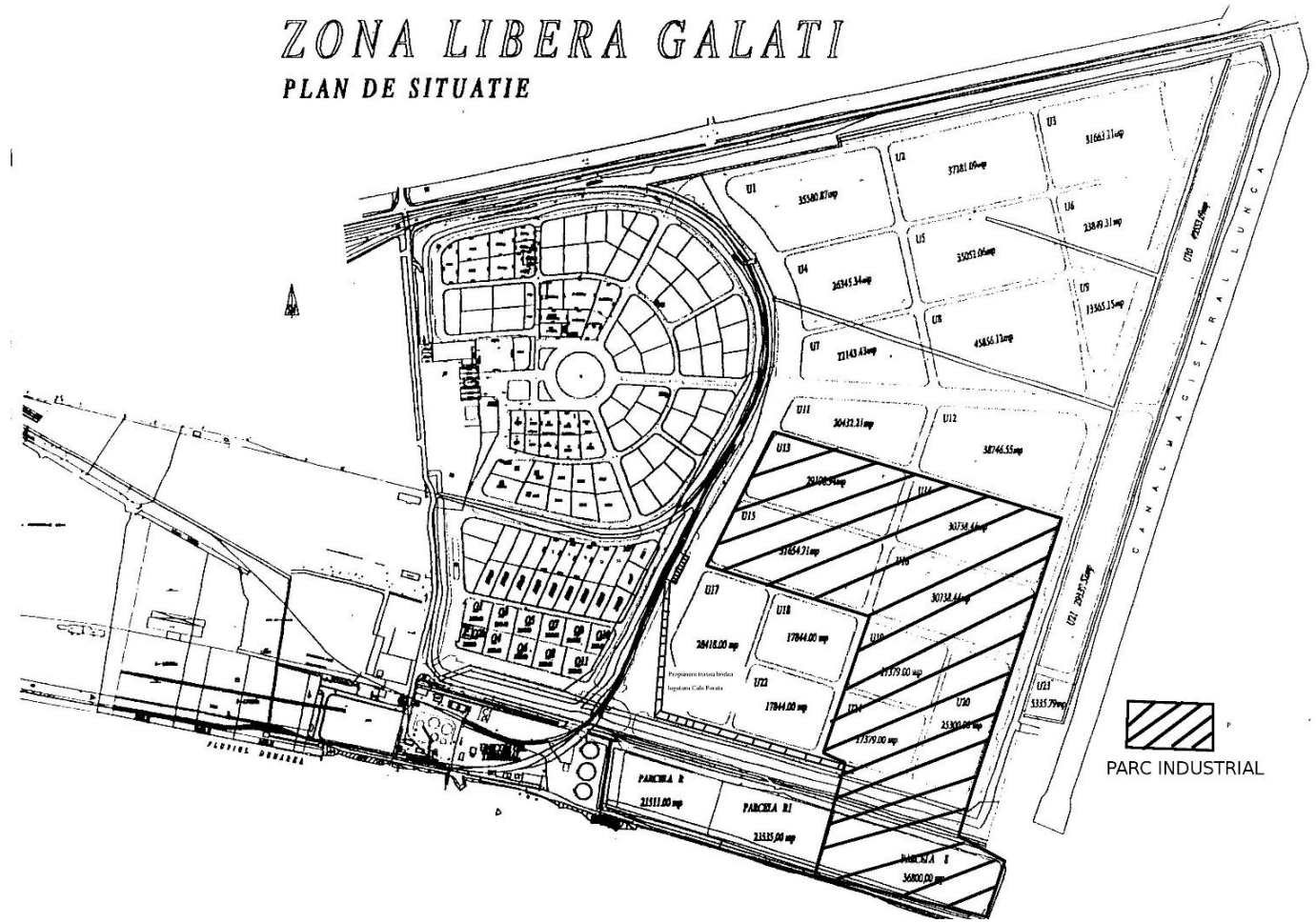

4 reasons to invest in galati free zone

Customs taxes

- customs duties are paid **only** in the moment when they are introduced in free circulation;
- station of goods inside Galati Free Zone is **not limited in time**;
- to introduce goods inside Galati Free Zone doesn't require **customs warranty** or declaration of a customs regime;
- transit of goods between free zones is also **exempted** from customs duties

V.A.T. EXEMPTION

- for goods exported from Galati Free Zone outside European Union space you **do not have to pay** customs duties and **VAT**;
- you have the advantage to deposit goods inside Galati Free Zone **without paying** any kind of customs duties or **VAT** up till the moment the goods are exported from Galati Free Zone towards community space and only for the quantity you want to sell towards community space (European Union space)
